World Gym Taiwan (2762.TW) Reports Solid July Sales and Record-Breaking Pre-Sales at New Locations; Overseas expansion plans rapidly progressing

Taipei, Taiwan – Aug 8th, 2024: World Gym Taiwan (2762.TW) today announced its revenue for July 2024 reached NTD 827.5 million, an month on month increase of 1.47% over June and bringing year-to-date revenue to NTD 5.62 billion, up 4.40% from the same period in 2023. The company also announced strong sales at the 5 new locations currently in presale, with plans to launch an additional 5 new presales over the next 60 days. These new locations are expected to boost revenue growth over the next two quarters.

Outstanding Pre-Sale Success at Five New Locations

The presale membership numbers at World Gym Taiwan's new branches - Kaohsiung Zuoying, Taipei Jingmei, Taipei Sanxia, Taichung Dali, and Nanzi Xingnan – have increased 57% over average new club presale performance in 2022 and 2023, reflecting stronger consumer demand for fitness. In particular, new member sales during the first month of presales at Kaohsiung Zuoying surged to over 2,100 members, setting a new company record.

To further capitalize on this momentum, World Gym Taiwan will launch an additional five new presales in August and September, to open in Q4, bringing total stores in operations to 130 by year end.

Broad-Based Growth and Future Outlook

As of the end of July 2024, year-to-date (YTD) growth compared to the same period in 2023 includes a 6.10% increase in membership revenue and a 2.77% increase in personal training (PT) revenue, underscoring a broad-based improvement across our services. The company is also rapidly progressing on its overseas expansion plan which it anticipates to announce over the coming months.

John Caraccio, President of World Gym Taiwan, stated, "We anticipate to continue modest growth at existing stores while accelerating new store growth. The impressive reception at our new locations shows that the demand for fitness is on the rise, which is excellent news for our company. We also hope to announce our overseas
